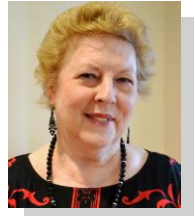

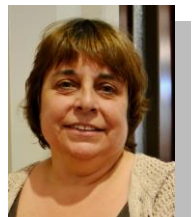

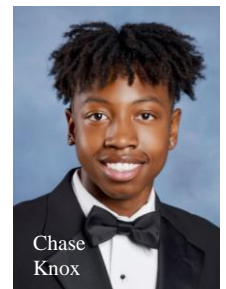

# LEGISLATIVE AND L/PEC SPRING/SUMMER, 2021, UPDATE

We are finally in a fading pandemic – one that has transformed all of our lives over the past 14 months or so. Thanks to science, the majority of us are fully vaccinated and are venturing outside and visiting our families without fear of contracting the virus while continuing to follow the CDC rules of safety.

By now, most have heard of the FBI investigation, along with the empaneling of a grand jury, to look into the operations of PSERS to gain factual insight on the functions and operations of that organization. Publicly, PSERS provides very little information about their operations. This is partly due to confidentiality agreements between PSERS and investment firms. However, the Federal Grand Jury is likely to recommend legislative action aimed at reform. There is a call to bring more transparency to PSERS and government in general. Multiple PSERS Board members, including former State Treasurer, Joseph M. Torsella, and current State Treasurer, Stacy Garrity, are ardent supporters of reform. The spotlight will be on PSERS and its return on investments, and it will drive more reforms in terms of practice and transparency that are more aligned with the practices and positions of PASR.

Please be aware that PASR and PSERS are separate operations without any direct connection; therefore, the investigation does not directly involve our organization. ## A Message from the Board of Directors

### PASR Statement on PSERS (May 26, 2021)

Due to recent news about issues involving the Public School Employees Retirement System (PSERS), the Pennsylvania Association of School Retirees (PASR) is compelled to respond as it funds our pensions in retirement. Since PASR represents only retirees and not active members, issues involving alleged malfeasance at PSERS significantly impact our members and their livelihoods.

PSERS has acknowledged that there is an active FBI investigation along with a federal grand jury investigation into its recent operations. At this time, there is no evidence or information leading to the conclusion that any pension has been placed in jeopardy.

Please note that PASR and PSERS are separate operations without any direct connection, therefore the investigation does not directly involve our organization.

#### **Reason for the Investigation**

There is a shared risk provision with active (non-retiree) PSERS members under Pennsylvania State Law that is based on an investment “window” of nine years. If PSERS investment returns fall below 6.36 percent over those nine years, a shared risk provision increases the amount that public school

employees, who were hired after July 1, 2011, pay into PSERS. Originally, PSERS certified that the nine-year return was 6.38 percent. Later, PSERS held a special meeting and changed the number to 6.34 percent which activated that shared risk provision.

News reports surfaced that indicated a possible investigation was underway at PSERS about the estimation of the nine-year investment return and the process it took to reach that number. Recently, additional reports have indicated that the investigation goes beyond the process of the estimation. At this point, it is speculation until there is a second-party validation.

As a result of the pending investigations, PSERS has acknowledged hiring at least four outside law firms to represent them. Also, PSERS has acknowledged hiring an additional outside consulting firm to help with investments during the time their staff is under investigation. This will result in additional money being spent in addition to normal management and personnel costs. PASR will seek information about the impact of those additional expenditures.

### **Next Steps**

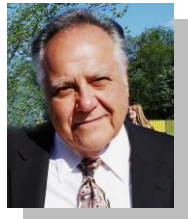
The PSERS investigation will take time to run its course, and we must respect that process. It is important to note that the average federal grand jury investigation usually takes anywhere from 12 to 18 months to complete.

PASR will closely follow this issue and we are committed to providing factual updates to keep you informed as the investigation progresses. We are here to be a trusted resource and will continue to advocate on your behalf.

We sincerely appreciate our members and leaders who have reached out to us to comment and seek additional information. We rely on feedback from our members, and we will continue to be responsive.

# **SOCIAL SERVICES MEMORIAL HONOR FUND**

The greatest job of every SSMHF local committee, including ours here in Delaware County, is to service confined and temporarily confined PASR members. Many local committees send cards to ensure that confined members know that their friends in the chapter care about them. Over 7000 cards were sent last year statewide to confined members and temporarily confined members who may not have been able to attend meetings. Many are in nursing homes, assisted living settings or hospitals, congregate care facilities, living with their children, or no longer able to leave home due to health issues. Over 1800 Gifts/flowers have been sent to these confined members in May and December of each year by the majority of chapters. These months are called Months of Giving by the local SSMHF teams. Many SSMHF committees regularly visit their confined members throughout the year. COVID halted this practice in 2020, but with more and more members being vaccinated, visits may begin again.

Each year, the state Memorial Honor Fund partially reimburses locals for the expenses incurred for the services they provide for their confined members. The Memorial Honor Fund uses another \$6000 yearly to help financially strapped members pay their state dues so that members can maintain their insurance coverage that requires this state membership. Lastly, the Memorial Honor Fund awards individual grants to members who are financially unable to maintain their expenses due to a catastrophic event. Due to limited funding, very few of these grants are awarded yearly. Happily, however, the PASR Board of Directors has provided \$5,000.00 to be used specifically for such persons; as such, we hope to be able to help more people.

With yearly costs of \$26,000, the Memorial Honor Fund is quickly depleting and will be gone within only a few years unless we can continue receiving donations yearly from chapters and members. **The SSMHF committees use no dues money to complete this work. All funding is from donations by chapters and individuals only.**

# Large-scale global study to investigate links between COVID-19 and cognitive decline

There is compelling evidence that COVID-19 will have long-term effects on the brains and nervous systems of survivors as they age, and researchers announced a large international study to investigate the correlation between the coronavirus and cognitive decline, Alzheimer's disease, and other dementia in later life.

Decades of evidence from other respiratory viruses, along with observations of patients in recent months, suggests such infections may increase a person's risk for Alzheimer's disease, Parkinson's disease, and other brain disorders, according to a paper announcing the study published in Alzheimer's & Dementia: The Journal of the Alzheimer's Association.

In the year since the coronavirus began spreading across the globe, doctors have noted lingering post-recovery conditions ranging from 'brain fog' and forgetfulness to anxiety, depression and psychosis. "Abnormal brain imaging has emerged as a major feature of COVID-19 from all parts of the world," the paper said, adding that brain abnormalities have been observed even in a person whose only symptom was anosmia, or loss of smell.

The societal and economic ramifications could be significant because of the pandemic's scale. Some COVID-19 survivors over 60 have reported short-term memory issues and trouble completing simple tasks that they used to do without any difficulty, such as planning a meal or cooking. This is all very recent, so we can't tell whether these are transitory problems or will become chronic.

Researchers hope to enroll a total of about 40,000 survivors. Some will be selected for the study from a pool of millions of confirmed COVID-19 cases. Others will be people enrolled in studies already underway, including one on cognitive function at Albert Einstein College of Medicine in New York.

## Executive Director's Report -- Adjusting Our Approach

Also, never far from our minds is the split that was caused by the passage of Act 9 of 2001. Many of our members retired before 2001 and were not able to take advantage of the multiplier increase established with the passage of Act 9. We want to fight for the rights and needs of all PASR members. At times, a special effort is required for those most in need. Many who retired before 2001 are having difficulty making ends meet. Recently, the Board of Directors approved the hiring of TRIAD Strategies as the Lobbyists that represent PASR. We thank former Lobbyist Jeff Hunsicker for his expertise and service over the past four years. His dedication to our members and his commitment to our success were appreciated. As we welcome TRIAD to the PASR family, we wish Jeff well in his future endeavors. Working with TRIAD, we will need to integrate our message and Association efforts toward educating the Pennsylvania General Assembly. Our message will always include a sense of urgency while making a compelling case for the critical need to pass this long-overdue legislation. TRIAD stands with us in this endeavor and will provide guidance as we work on behalf of our members.
